


Figure 1. Forward Characteristics





Figure 2. Reverse Characteristics




Figure 3. Current Derating




Figure 5. Recovery Charge vs. Reverse Voltage

Figure 4. Power Derating




Figure 6. Capacitance vs. Reverse Voltage






Figure 7. Transient Thermal Impedance

#### **Recommended Solder Pad Layout**


